Minimum Eligibility Criteria for qualifying in the Technical Bid.

Eligibility Criteria for Selection of Contract manufacturer under Bottling cum Distribution Hub:

- 1) Bottling/ Packing cum distribution hub for Home/FMCG Product at Northern /Southern/Western India for outright sale/Transport charge of bulk.
- 2) Our key home products like Pheneol/White Tiger/Cantheridine Hair oil etc. will be transported to such hubs through tanker and to be bottled there. Therefore, the Party should have desired facility for bottling as per the specification given by BCPL.
- 3) Similarly, Bulk of Naphthalene & Bleaching Powder to be supplied in bulk to the hub & Packing from Paty's with BCPL'S LOGO embossed, which will be repacked to appropriate pack sizes by the party.
