#### **Reverse Auction:-**

The Reverse Auction Process will be carried out where all the technically qualified bidders will be allowed to participate in the Reverse Auction. The bidders have to continuously submit their prices on the reverse auction floor, which should be lower than the "ceiling price" or the "current L-1 bid". This process will continue till the end of the schedule time for closing Reverse Auction.

All the technically qualified bidders shall be informed regarding the date and time of commencement and closure of Reverse Auction through e-mail.

## **REVERSE AUCTION PROCESS:**

- **1. PRICE TO BE QUOTED IN THE PRICE BID :** The bidders should quote the Price as per the online form and the price bid should be uploaded along with techno commercial bid at the time of submission of offer. The Price quoted should be in INDIAN RUPEES only.
- 2. The price bid submitted by the bidders along with their techno-commercial bid shall be kept in electronic locking system and once the reverse auction starts, system will fetch the L-1 landed price from the price-bids and the same shall be treated as "Ceiling Price" for Reverse Auction process.

  - Ceiling Price (Lowest landed price fetched automatically from the qualified e-price bids).
  - Space in the column "MY BID" for filling the price by the bidder. Bidder has to fill their fresh price (i.e. landed price) in this column and submit their bids during the reverse auction.
  - Current status of the bidder (Once the bidder fills in the price, the current status of the bidder will be indicated) in the column "Rank/Current Bid".
  - Drop down list of bid values indicating their current ranking. (This indicates the bid values and their current ranking. However, the names of the bidders are kept anonymous)

#### **AUTO EXTENSION OF TIME:**

➤ The Auction floor for Reverse Auction shall remain open up-to a pre-determined time, which will be intimated to the qualified bidders in advance.

Initially the Reverse Auction period will be for 3 (three) hours from the time of commencement of the Reverse Auction. There will be a provision of auto extension of the bidding time by 15 minutes, if a bid lower than the L1 bid is received within last 5 minutes of the closing time. Number of Auto Extensions shall be limited to 5 (five).

In case no bid is placed in last five minutes of the closing time or during the extended closing time, the Reverse Auction will be closed.

For Example: If the final closing time for Reverse Auction is scheduled at 17.00 hrs (System time). If a bidder has quoted a price lower than the last L1 bid at 16.58 hrs. ## General Terms & Conditions

- 1. Mere participation in e-tender will not mean that a particular bidder will be automatically considered qualified and their bids will be entertained. Such qualification will be reviewed at the time of evaluation of bids also.

It is not obligatory on the part of the Trustees to accept of Lowest Tender. They reserve the right to accept a Tender in full or in part and/or reject a Tender without assigning any reason thereof.
- 6. If Micro & Small Enterprises (MSEs) registered with NSIC intends to participate in the tender, for the items they are not registered with NSIC, then they will have to deposit cost of Tender Document (if), full amount of Earnest Money (if) as per NIT.
