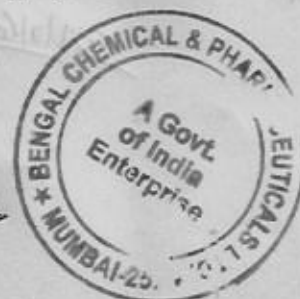

1. The rate quoted should be firm and valid up to 22/06/2018 and should be inclusive of all charges, including loading, unloading, hamali, statistical or any other charges required for transportation of goods. The bid should provide the break-up of each head to arrive at the quoted rate.
2. RISK PURCHASE : The Transport contractor shall place their Lorries within 24 hours of information to them in case of full truckloads dispatches. Non-placement/refusal on time for consecutive two occasions risk purchase clause will be imposed i.e. Company will hire the vehicle from other sources and difference of payment will be recovered from their pending bills.
3. In case of small consignments (Part load consignment) has to be lifted by the Transporters from our Factory on intimation and supply should be effect on "Door Delivery Basis".
4. No Transshipment will be allowed. If transshipment is proved BCPL management will be at liberty to impose penalty on a Rs.1,000/- per day on each day of delay or shall discontinue the contract altogether.
5. Transporter will be liable for any loss due to pilferage, damage or transshipment or otherwise, theft of materials or accidents and fire the matter should be informed to BCPL within 24 hours of occurrence along with Police FIR. In such case however Company reserves the right to recover the amount of loss by deducting from the bills of the transporters.
6. BCPL will not be liable to pay any detention charge for delay caused in unloading at the consignee level. In case however the consignee is a customer, BCPL will negotiate with the customer for the early release of the consignment. If the customers agree to pay detention charges such charges will however be payable to transporters.
7. Payment will be made by BCPL through Cheque within 60 days from the date of delivery at the respective depots supported by documents of delivery and goods received in good conditions or certificate of damage and / or short received.
8. In case of dispatch by full truckload, the transporters are not permitted to transport any other materials, not belonging to BCPL, in the same truck even if some space may be available.

9. The Company reserves the right to accept or reject any or all quotations in part or in full at any time contract without assigning any reason whatsoever.

10. PRICE ESCALATION CLAUSE : Rate revision during the tenure of the R.C. may be allowed by BCPL only if the Diesel Price increases significantly during the period for more than 5%. This means :

- a) Up to 5% increase in Diesel Price, no request for Rate Escalation will be entertained.
- b) In case of Diesel Price having been increased by more than 5%, a price escalation of the actual percentage of Diesel Price Hike will be considered e.g. if during the R.C. period Diesel Price is increased more than 5% the R.C. Rates will be hike by the following manner i.e.  $(\text{hike in } \% - 5\%) / 2$

11. PRICE DE-ESCALATION CLAUSE : Rate revision the tenure of the R.C. may be allowed

by BCPL ONLY IF THE diesel decreases significantly during the period for more than 5%.

This means :

- a) Up to 5% decrease in Diesel Price, no request for Rate De-Escalation will be entertained.
- b) In case of Diesel Price having been decreased by more than 5%, a price De-Escalation of the actual percentage of Diesel Price reduction will be considered e.g. if during the R.C. period Diesel Price is decreased more than 5% the R.C. Rates will be reduced by the following manner i.e.  $(\text{decrease in } \% - 5\%) / 2$ .


12. PENALTY CLAUSE : 1) delay in delivery more than two days beyond stipulated period of particular destination would be charged @ Rs.1000/- (Rupees One thousand only) per day (as mentioned in the Tender Paper).

2) In case of our material is ready before scheduled delivery period for CSD supply, but transportation is not available, then the penalty amount will be as same as deducted by the party (CSD).

13. If any materials are broken during loading and unloading period then the value of the goods are to be deducted as per trade price from the transporter.

Similar values of short delivery items are to be deducted as per trade price from the transporter.

14. BCPL will specify whether they need 4 MT/ 9MT/ 16MT Trucks at least 24 hours before Schedule. Since load cannot be exact, the Transporter must be prepared not to claim any additional amount up to 4050 Kgs./9100 Kgs./16,200 Kgs. However, in case of request by BCPL to accommodate some extra load, Transporter will accept the same.





15. The Transporter's Representative / Personnel must properly count C.B. Boxes. Any claim on a later date of having receipt less than what has been mentioned in the consignment note will not be entertained.

16. INSURANCE CLAUSE:

- A) BREAKAGES/DAMAGES: The value of the Broken/Damaged stocks will be considered as per the rates mentioned in the challan and the whole amount will be deducted from the Transporter's Bill.
- B) ACCIDENT/NATURAL CALAMITY: In case of accident or natural calamity, which may cause extensive Breakage, Damage, Surveyors of M/s. Oriental Insurance Co., will be called and the Company will lodge claim. However, in the event of an accident responsibility of making a FIR to the local Police Station and to take a photograph and submit the same to BCPL lies on the Transporters.
- C) SHORTAGES: While receiving the consignment, if open/ torn C.B. Boxes are found BCPL's concerned Depots shall insist on taking "Open Delivery" and after counting the contents, shortages if any, will be reported. Loss incurred due to these shortages, will be recovered from the Transporters Bills.
