

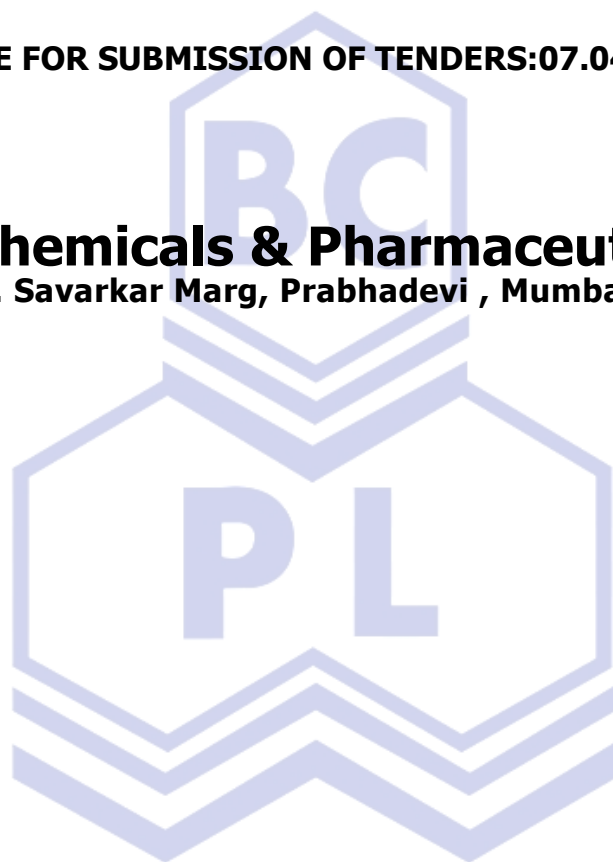

INSTRUCTION TO THE TENDERERS

The Tender shall be submitted in accordance with the instructions and any tender is not comply with the instructions as under is liable to be rejected. These instructions shall form the part of the tender and contract.

1. The tender should be submitted in **sealed cover** super-scribed as **"SALE-OF-SCRAPS"**.
2. The Tender shall be submitted along with the Earnest Money Deposit (EMD) declaration document as specified as Annexure- V
3. The tender shall be completed in all respect and should be signed with date by the Authorized Signatory of Tenderer on all the pages.
4. The offer prices shall be quoted for the scrapper kg basis **"AS IS WHERE IS BASIS"** plus GST Extra
5. The Tenderers are free to inspect the Scrap at the above address of Bengal Chemicals & Pharmaceuticals Ltd, 502 S.V. Savarkar Marg, Prabhadevi, Mumbai-400025 on any working day from w.e.f. **01.04.2023 to 07.04.2023** in the presence of BCPL Officials.
6. The tender shall be awarded based on the highest offer received for individual item/stock. In other words, the successful bidder would be decided for each item based on the highest offer received for particular item. Accordingly the delivery of each item would be issued separately to selected bidder for that particular item. Up on award of the contract, the particular highest bidder shall deposit an amount equivalent to the 2% of the actual value of the scrap item as a Performance Guarantee which shall be returned to the party without any interest up on successful completion of the lifting of the items or within 60 days whichever is earlier.

7. Procedure for disposal of Scrap:

- a) The successful Tenderer shall deposit the total lump sum amount in Rupees for individual category of scrap as detailed under annexure IV by way of Demand Draft/Pay Order in favor of **"Bengal Chemicals and Pharmaceuticals Ltd"** payable at Kolkata towards the cost of Scrap (approx) within three working days from the date of awarding the order.

The details of lump sum amount to be paid for individual category of scrap shall be calculated as per the formula as under:

- b) The truck/tempo for Scrap lifting and carrying shall be arranged by tenderer at their own cost. The tenderer shall have to make arrangement for loading of scrap to truck/ tempo at their own cost and BCPL, Mumbai will not pay any charges for the same.
- c) Prior to the loading of scrap on the Truck/Tempo, the empty Truck/Tempo shall be taken to the Weighing Bridge for weighing in presence of official from BCPL-Mumbai
- d) The loaded truck would again be sent to the weighing scale for weighing, and the weight of material would be calculated for payment of quantity of scrap based on the quoted price. The Weighing Bridge will be decided at random by BCPL official and the weighing bridge charges (if any) shall be borne by the bidder.

1. Tenderers shall submit their offers in a sealed cover super scribed as **"Tender for Sale of Scrap"** to this office on or before **07.04.2023 upto 17.00 Hrs.**
2. Tenderers shall take into account the cost of labour, loading & cartage etc. for taking delivery from the premises of BCPL-MUMBAI before quoting the rates. In this regard no claim what so ever shall be entertained by the BCPL-MUMBAI. BCPL-MUMBAI shall hand over the scrap to successful tenderers on the place where it is actually lying presently in the Campus.
3. The successful Tenderer shall bear the cost of weighing the empty & loaded Truck/Tempo.
4. BCPL-MUMBAI officials shall accompany the Truck/Tempo arranged by the successful tenderer for weighing. The weighing bridge selected by BCPL-MUMBAI officials for weighing the empty/loaded truck/tempo shall be binding on the Tenderer. The empty Truck/Tempo shall be directly brought to the BCPL after weighing.
5. Rate quoted will be valid upto 03 months from the date of awarding the order. The rate contract can be extended for another 3 months on mutual agreement and the terms & condition shall remain same.

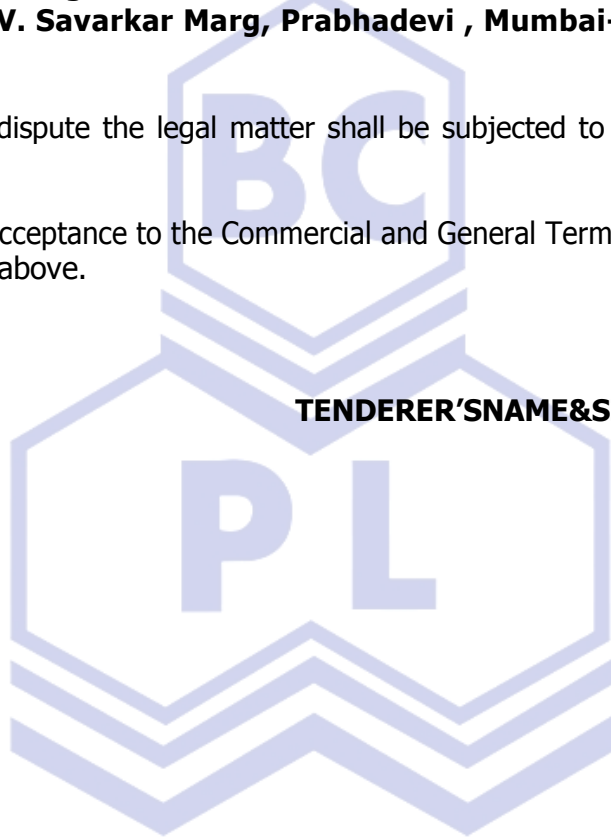
